# MARINA BAY SANDS GIFT AND ROOM STAY CERTIFICATES FACT SHEET

The Marina Bay Sands Gift and Room Stay Certificates make ideal gifts for friends, relatives and loved ones for any occasion from weddings to birthdays. They can also be purchased by companies wanting to reward their employees with an extra special gift, or as corporate incentives for valuable clients.

The Marina Bay Sands Gift Certificates are valid for use at more than 200 participating stores and restaurants across the Marina Bay Sands complex, including the Celebrity Chef Restaurants, the Sands SkyPark<sup>®</sup>, Banyan Tree, Skating Rink, Theatres, Sampan Ride and ArtScience Museum.

The Room Stay Certificates are valid for a one night stay at the prestigious Marina Bay Sands Hotel®, Singapore.

The purchase of all Certificates is governed by the Terms and Conditions stated below:

## TERMS AND CONDITIONS

#### Marina Bay Sands Gift Certificates

- 1. Gift Certificates can only be redeemed at the outlets participating in this promotion at the date of redemption. The current participating outlets are listed in the Appendix to this Factsheet. This list may be altered or amended at any time without further notice.
- 2. Gift Certificates are available for purchase in the following denominations: \$20, \$50 and \$100. The Gift Certificates cannot be bought using Sands Points or Sands Dollars
- 3. The minimum Gift Certificate purchase is \$20
- 4. The value of any Gift Certificate must be used in a single transaction: no refund will be given for any unused portion. If the user wishes to purchase item(s) of a value greater than the Certificate, he may use the Gift Certificate as part payment and pay the remainder with another form of payment
- 5. Gift Certificates cannot be used or redeemed towards previous purchases and cannot be used or redeemed to purchase other Gift Certificates
- 6. Where Gift Certificates are sought to be redeemed against tickets (eg at the Theatre), advance booking is required, and subject to availability.

#### Marina Bay Sands Room Stay Certificates
