

## Sands LifeStyle – Sands LifeStyle Shopping Fest Promotion for period from 15 to 18 June 2024

### Promotion and General Terms and Conditions

1. **Terms.** The Terms and Conditions hereunder (“**General T&Cs**”) and any other applicable specific Terms and Conditions relevant to this Promotion (“**Other T&Cs**”), together with any amendments as may be made from time to time, shall form a legal agreement between Marina Bay Sands Pte. Ltd. (“**MBS**”) and you. By participating in this Promotion, you confirm that you have read, understood, and agreed to be bound by the General T&Cs and Other T&Cs (collectively, the “**Rules**”). In the event of any conflict or inconsistency between these General T&Cs and the Other T&Cs, the Other T&Cs will prevail followed by the General T&Cs.
2. **Promotion.** 6.18 Sands Shopping Fest – Spend a minimum accumulated spend of \$618 (before applicable taxes are applied) at The Shoppes and stand to receive Bonus Resort Dollars (“**Promotion**”).
3. **Promotion Period.** This Promotion will take place from 15 June to 18 June 2024 (“**Promotion Period**”). This Promotion will expire at 11.59pm on 18 June 2024, after which, no further participation in this Promotion will be permitted.
4. **Eligibility and Participation**
  - a. To be eligible to participate in the Promotion and receive Bonus Resort Dollars, you must:
    - i. Be a Sands LifeStyle (“**SL**”) member, in good standing and be eighteen (18) years of age or older. If you are not an existing SL member, you can sign up for SL membership through the MBS App or at any MBS SL counters or on the MBS’ website (<https://www.marinabaysands.com/sands-lifestyle/sign-up.aspx>);
    - ii. Present your SL membership card when you spend an accumulated minimum of \$618 (before applicable taxes) (“**Minimum Spend**”) at any of the participating outlets where payment (excluding Goods and Services Tax (‘GST’) and service charge) is made by cash, NETS, credit card, debit card, mobile or online payment, mobile or digital wallet and secure funds transfer service (subject to the aforesaid payment methods being offered by the relevant Sands Participating Outlet) at MBS listed at <https://www.marinabaysands.com/sands-lifestyle/shopping-fest.html> (“**Participating Outlets**”) during the Promotion Period;
    - iii. Prior or after meeting the Minimum Spend, perform a one-time activation via the Marina Bay Sands Mobile App <http://www.marinabaysands.com/appdl> (“**Activation**”) any time between 10.00am on 10 June 2024 to 11.59pm on 18 June 2024, to register for the Promotion and receive the Bonus Resort Dollars;
    - iv. Not fall within any of the following categories of persons: (a) advertising agencies (and affiliates) of MBS; (b) employees of MBS tenanted retailers managing transactions; and
    - v. Satisfy any other eligibility criteria (“**Qualifying Participant**”).
  - b. If you are not a Qualifying Participant and have participated in this Promotion, MBS reserves the right to disqualify your participation as well as seek the return of any payment, award, or prize (including such payment, award or prizes credited to any of your membership accounts with MBS) from you.
  - c. MBS further reserves the right to disqualify your participation in this Promotion if:
    - i. You have cheated or committed a fraud;
    - ii. Tampered or attempted to tamper with the entry process/operation of this Promotion;
    - iii. Manipulated or attempted to manipulate the operation of this Promotion; or
    - iv. Your conduct is in breach of the Rules including providing false information (such as fake accounts, personas or photos) or deliberately withholding information.

5. **Bonus Resort Dollars.** Qualifying Participants will receive Bonus Resort Dollars worth up to 8% of their total spending (before applicable taxes). 6. Qualifying Participants who wish to receive the Bonus Resort Dollars after meeting the Minimum Spend with the Participating Outlet(s) during the Promotion Period must remember to complete the Activation, as set out in Section 3(a)(iii) above.
7. Transaction(s) made during the Promotion Period at a Participating Outlet will be considered for the Bonus Resort Dollars upon Activation.
8. Bonus Resort Dollars will be credited into the respective Qualifying Participants' accounts within 48 hours after Activation. In the event of technical issues, Qualifying Participants' accounts will be updated after the system is back online, or such other time as MBS may determine in its sole discretion.

- b. Complying with the Company’s internal policies, any applicable law/regulation and request/direction of any applicable authorities of any relevant jurisdiction that is binding on the Company; and
- c. Marketing and advertising the Company’s business within and outside of Singapore. For this purpose, you grant MBS a licence to Use your personal data, including your images and likeness, and waive all claims for payment for such Use.

Please note that MBS may be unable to administer the Promotion without your consent to the above.

14. **MBS Liability**

- a. MBS will not be responsible for (i) electronic transmission errors or delays resulting in your inability to participate or other loss, (ii) theft or destruction of or unauthorised access to or unauthorised alterations of materials, or technical, hardware, software failures of any kind, (iii) lost or unavailable connections, or delayed computer transmissions, whether caused by MBS, users, or by any of the equipment or programming associated with or utilised in this Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent your ability to participate in this Promotion, or (iii) any loss of opportunity to participate in this Promotion for any reason whatsoever.
