## Marina Bay Sands Guided By an All-Female Legal Team

Prior to joining Marina Bay Sands, Ms. Lim was Group Legal Counsel and Group Company Secretary for GuocoLeisure Limited, a member of the Hong Leong group. Having joined GuocoLeisure in 2008, she reported directly to the Executive Chairman and the Group Chief Executive Officer. Ms. Lim's appointment at GuocoLeisure saw her supervise and manage legal and regulatory teams based in Singapore and London on transaction and litigation management and operational matters ranging from mergers and acquisitions to commercial contract negotiations, banking and finance, litigation and arbitration cases as well as liaise with the Singapore, London and New Zealand stock exchanges on regulatory compliance issues.

Ms. Lim was previously Regional Counsel, Asia Pacific and head of the legal team for the management consulting business in Asia Pacific of a Big Five accounting firm. Prior to that, she practiced as a senior mergers and acquisitions, securities and corporate lawyer with leading international and local firms in Hong Kong and Singapore.

Ms Penny Lo, previously Associate General Counsel at Marina Bay Sands, has been promoted to Deputy General Counsel. Ms. Lo is a lawyer of more than 13 years standing. She possesses a wealth of regional corporate legal experience obtained in private practice and working in-house for a large US multinational based in Shanghai. She has developed expertise in navigating the distinct legal and regulatory environment in which Marina Bay Sands operates.

Ms. Lo graduated from the National University of Singapore in 1993 with an LLB Honors, and went on to pursue her Masters in Business Administration at Europe's premier business school, INSEAD.

Both Ms. Lim's and Ms. Lo's appointments take effect immediately.
