#### SANDS REWARDS LIFESTYLE DINE & WIN PROMOTION AND RULES

# A. <u>F&B Offer Redemption and Mystery Lucky Prize</u>

9. SRL members must be one of the diners and must present their SRL membership card along with their original printed kiosk slip at the applicable F&B outlet in order to redeem the F&B treat.

# B. <u>Race to Collect</u>

10. First 288 SRL members who have collected all unique stamps on Dine & Win Passport and identify themselves at the designated counter located at B1 event area (above Sampan Ride) before 28 October, Sunday, will be eligible to redeem a Marina Bay Sands collectible dinnerware set.
