# KIDS DINE FREE CAMPAIGN 2018 VOUCHER REDEMPTION

Terms and Conditions

MBS Retail Management Company Pte Ltd (the "Organiser" or "MBSRM") is the organiser of the "Kids Dine Free" promotion ("Promotion").

#### 1) Terms

The terms and conditions herein ("General T&Cs"), together with any amendments as may be made from time to time, shall form a legal agreement between MBSRM and you. By participating in this Promotion, you confirm that you have read, understood and agree to be bound by the General T&Cs. You also agree to accept terms and conditions of any gift, voucher, coupon or any other item which participant may redeem or receive in connection with this Promotion.

### 2) Promotion Period

The Promotion Period is from 15 December 2018, 10.30am until 31 March 2019, 11:00pm, unless otherwise stated. This Promotion will expire at the end of the Promotion Period at which time, no further participation in this Promotion will be permitted.

# 3) Eligibility and Participation

- a) In order to qualify for the Promotion, the participant must purchase the stated minimum number of tickets from any of the following Marina Bay Sands' Attractions – ArtScience Museum, Digital Light Canvas and Sands SkyPark Observation Deck.
  - i. At least one adult (1) ticket and one child (1) ticket to any exhibitions at the ArtScience Museum
  - ii. At least one adult (1) ticket and one child (1) ticket to the Sands SkyPark Observation Deck
  - iii. At least one adult (1) ticket and one child (1) ticket for the Attractions Bundle Deal Package

For the purposes of receiving the Children Meal Voucher, the participant shall provide any identification as required by MBSRM or its affiliates.

- b) The Children Meal Voucher is only valid for children 12 years old and below and for the children's menu with an order of a main course at the participating restaurants.
- c) The Children Meal Voucher is valid for use only at participating restaurants within The Shoppes at Marina Bay Sands. Participating restaurants are DC Comics Super Heroes Cafe, Ippudo or Yardbird Southern Table Bar. Additional participating restaurants may be included at MBSRM's discretion. The specific items available for redemption shall be at the participating restaurants' discretion.
